

4. First Aid Measures

Always seek medical attention after first aid measures are provided.

<u>Inhalation:</u> If inhaled, remove the victim to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen and get medical attention immediately.

<u>Ingestion:</u> Do not induce vomiting unless as directed by medical personnel. Never give anything by mouth to an unconscious person. Get medical attention.

<u>Skin Contact:</u> Immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Get medical attention. Wash clothing and shoes before reuse.

<u>Eye Contact:</u> Remove contact lenses. Immediately flush eyes with plenty of water for at least 15 minutes, lifting lower and upper eyelids occasionally. Get medical attention immediately.

5. Fire Fighting Measures

Fire: Flammable.

<u>Fire Extinguishing Media</u>: Dry chemical, alcohol resistant foam, fog or carbon dioxide. Water can be used to cool and protect exposed material. Do not direct a solid stream of water on spilled material. Use flooding amounts of water as a fog. Use water to cool containers exposed to fire. A solid stream of water will spread the burning material. Material creates a special hazard because it floats on water.

<u>Products of Combustion</u>: These products are toxic fumes, carbon oxides (CO, CO2) and sulfur oxides (SOx). <u>Special Information</u>: In the event of a fire, wear full protective clothing and NIOSH-approved self-contained breathing apparatus with full face piece operated in the pressure demand or other positive pressure mode. <u>Protective Equipment</u>: Gloves. Synthetic apron. Vapor and dust respirator. Be sure to use an approved/certified respirator or equivalent. Wear appropriate respirator when ventilation is inadequate. Splash goggles.

6. Accidental Release Measures

<u>Personal precautions, protective equipment, environmental precautions and emergency procedures</u>: Avoid breathing dust/fumes/gas/mist/vapors/spray. Use individual protective equipment (waterproof boots, suitable protective clothing, safety glasses, etc). Restrict unprotected personnel from the area. Prevent any contact with hot surfaces. Do not approach facing the wind. Do not touch the spilled material. Keep away from drains, surface and groundwater and soil.

Methods and materials used for containment Cleanup procedures and Storage:





Small Spill: Use appropriate tools to put the spilled solid in a convenient waste disposal container. Large Spill: Contain spilled material. Stop leak if without risk. Avoid breathing dust, mist or gas. Soak up with inert absorbent material. Keep in suitable, closed containers for disposal. Ensure adequate ventilation. Evacuate personnel to safe areas. Prevent entry into sewers, basements or confined areas; dike if needed. Eliminate all ignition sources. Avoid exposure - obtain special instructions before use.

7. Handling and Storage

<u>Precautions for safe handling</u>: Apply according to good manufacturing and industrial hygiene practices with proper ventilation. Wash thoroughly after handling. Do not drink, eat or smoke while handling. Use with adequate ventilation. Minimize dust generation and accumulation. Avoid breathing dust/fumes/gas/mist/vapors/spray. Avoid contact with eyes, skin, and clothing. Keep container tightly closed. Avoid ingestion and inhalation. Use individual protective equipment (waterproof boots, suitable protective clothing, safety glasses, etc). Prevent any contact with hot surfaces. Containers of this material may be hazardous when empty since they retain product residues.

<u>Conditions for safe storage, including any incompatibilities</u>: Store in cool, dry and ventilated area away from heat sources and protected from sunlight in tightly closed original container. Keep air contact to a minimum. Store protected from heat, sparks and ignition sources and incompatible materials. Avoid contact with skin and eyes. Avoid inhalation of dust/mist/vapor. Do not store with incompatible materials like strong oxidizing, strong reducing agents and bases.

8. Exposure Controls/Personal Protection

<u>Skin Protection:</u> Wear impervious protective clothing, including boots, gloves, lab coat, apron or coveralls, as appropriate, to prevent skin contact.

<u>Eye Protection:</u> Use chemical safety goggles and/or full face shield where dusting or splashing of solutions is possible. Maintain eye wash fountain and quick-drench facilities in work area.
